



<u>Key Text</u>:

"Think not that I am come to destroy the law, or the prophets: I am not come to destroy, but to fulfil."—Matthew 5. Verse 17

<u>Summary</u>:

Often, we associate the person and work of Jesus Christ with the word "gospel," and rightly so. But it may and must also be associated with the law of God. In this module, we learn why the Lord Jesus is called the "last Adam," and how that is related to his announcement that he didn't come to destroy the law of God. We also learn how Jesus fulfilled the law of God.

9. How did Jesus underline the permanence of the law? Why did the Lord Jesus warn us about rewriting, ignoring or cancelling any part of the Ten Commandments?

10. In summary, what is the relationship of the law to the gospel in the life of Jesus?
