



<u>Key Text</u>:

"Therefore by the deeds of the law there shall no flesh be justified in his sight: for by the law is the knowledge of sin."—Romans 3, verse 20

<u>Summary</u>:

In this lecture, we learn what the law is not in terms of our salvation. We consider how God brings sinners to an awareness of ourselves and to the need for the Lord Jesus Christ and his salvation. We discover the indispensable role of his law. We also learn how the law and the gospel work together in God's saving ministry. Finally, we are reminded of the false teaching of legalism.
