

Lecture Title:

Handling God's Resources

Key Text:

"Thou Shalt Not Steal."—Exodus 20, verse 15

Summary:

Did you know that no earthly subject gets as much attention in God's Holy Scriptures as the subject of money? God knows where our chief temptations lie, and therefore it is of his goodness that he legislated the Eighth Commandment. But the extent of "not stealing" is much broader than literal theft. God also calls us to be good stewards of what he allows us to possess on earth.

Review Questions:

1. What does the eighth general principle teach us practically? How does the Bible support this principle? What should we avoid?
2. What are the underlying assumptions of the Eighth Commandment? What resources God has given unto you?
3. How are we to understand the exhortation in 1 Peter 4, verse 10? How do other Scriptures support the truth that we don't own our possessions: we are stewards of God's?
4. Do people have the right to have private possessions? Is a forced redistribution of wealth in money or land a biblical command?
5. What are the lawful ways of acquiring possessions? What does the Bible teach us about the lawful means of working?
6. What are the unlawful ways of acquiring possessions that God forbids?
7. What are the spiritual applications of "Thou shalt not steal"?

8. How are we to understand the command to tithe? It is just a church rule or is it a spiritual test of God? What are the other purposes of this command?
9. How are we to be good stewards of God's resources?
10. What does James chapter 5 teach about the sin of stealing?
Further Application: 1. Meditate on this commandment by considering the positive responsibilities and the things that are forbidden. Read the Heidelberg Catechism and the Westminster Shorter Catechism about this commandment.
